

Summary Annual Report

This is a summary of the annual report for the Lam Research Corporation Short Term Disability Benefit Plan, (Employer Identification No. 94-2634797, Plan No. 505) for the period January 1, 2021 to December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Lam Research Corporation has committed itself to pay the following types of claims incurred under the terms of the plan.

All Short-Term Disability claims

The value of plan assets, after subtracting liabilities of the plan, was \$-365,785 as of December 31, 2021 compare to \$-112,854 as of January 1, 2021. During the plan year the plan experienced a decrease in its net assets of \$252,931. This decrease includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$3,742,303. This income included employer contributions of \$2,500,000 and employee contributions of \$1,242,303. Plan expenses were \$3,995,234. These expenses included \$77,726 in administrative expenses and \$3,917,508 in benefits paid to participants and beneficiaries.
